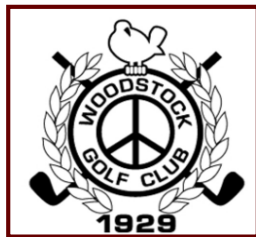

Minimal of 44 players are required to close the course. The tournament director is required to complete the tournament form with this application. The director should also notify the Pro Shop at least 2 weeks prior to the event to verify the number of players. A \$300 nonrefundable deposit is required to reserve the date. The deposit will be applied to the fee the day of the tournament. This deposit must be received 90 days prior to the event.

Tournament fee per golfer \$45.00 includes 18 holes of golf, electric cart. Food and beverage requests are available and contracted directly with our restaurant operator. Sample menus on other side, call for details and assistance in customizing your event.

It is customary to spend \$6 per player of your prize budget in the Pro Shop for merchandise and/or gift certificates.

Please include the following rules with your application:

1. Golf attire required. This includes a collared shirt, slacks or shorts not more than 4" above the knee.
2. Athletic shorts, sweat pants, worn or work jeans, spandex or short shorts will not be allowed on the course.
3. Soft spikes or smooth soled shoes only.
4. Golfers must replace divots, repair ball and rake bunkers.
5. **Golf carts** are limited to two (2) players, **must** stay on paths by tees & greens, and kept at least 30 ft. from the greens at all times.
6. **Alcoholic beverages must be purchased through the club.** Alcohol brought to the facility by participants will be confiscated.
 - Anyone in violation of the rules of WGC and/or tournament rules will be asked to leave **no refunds.**
 - **The tournament director shares the liquor liability with the Club and is responsible for the dress and conduct of the event participants.**
 - *The participation of players whose access to our facility has been restricted for any reason must be approved by the Woodstock Golf Club prior to the event*
